1. Call to Order

2. Chair's Opening Remarks

Inaugural meeting of the Intermunicipal Servicing Committee.

3. Adoption of Agenda

4. Approval of Terms of Reference

Motion: That the Calgary Metropolitan Region Intermunicipal Servicing Committee approve the Terms of Reference as presented with the following exception:

In the section 'Additional Items', the phrase 'may potentially' shall be replaced with 'will'. This formalizes the inclusion of recreation in the scope of the Intermunicipal Servicing Plan.

Motion carried unanimously.

5. Update to Committee on list requirements from Regulation

For information, Chair Sheard reviewed the requirements from the MGA and the CMRB Regulation, and the differences between Intermunicipal Collaboration Frameworks and the Servicing Plan. In response to queries from the Board around the requirements of the Servicing Plan, Chair Sheard met with Municipal Affairs to clarify the intent. To the extent the items under the servicing plan requirements are needed or helpful in putting together the land use plan, efforts should be made to align with the requirements.

6. Topic Grouping Outline

Jaime Graves reviewed the table and highlighted the interconnectedness of the servicing plan with the land use plan.

7. Update from Technical Advisory Group

Jaime Graves updated the Committee on work being done by TAG which will ultimately be presented to this committee, including the following decision made at the Land Use Committee authorizing CMRB administration to:

- o Update population projections by region and by municipality
- Update employment projections by region
- Update CRP projections to:
 - Reflect current regional boundaries,
 - Incorporate 2016 census data, or the most currently available census data
 - Incorporate current economic conditions,
 - Other
- Adopt an approach to employment projections which identifies concentrated areas rather than municipal-wide employment.
