6. Interim Regional Evaluation Framework Guide

Liisa Tipman reviewed the background and purpose of the Guide. Clarification on aspects of the Guide was requested, and the Chair directed Liisa to bring the Guide to an upcoming TAG meeting for discussion. If time constraints are a concern at TAG, Liisa will meet individually with any member municipality that has questions.

7. IREF Consultant RFQ

Jordon Copping discussed the third-party consulting services with the Land Use Committee and answered questions. He noted the RFQ would be created with input from the Land Use TAG and subsequently posted on the Alberta Purchasing Connection.

Moved by Mayor Genung, **Seconded by** Reeve Spilak, accepted by Chair **Motion:** That the Calgary Metropolitan Region Land Use Committee grant authority to CMRB administration to develop a Request for Qualification for thirdparty consulting services to provide application review services. **Motion carried unanimously.**

Liisa Tipman presented a request to develop a high-level framework for the public consultation and engagement process, leading to the posting of an RFP for a consultant. The Land Use Committee suggested that a communications framework should be developed first, and is critical to the public consultation and engagement process.

Summary


- On October 4 and October 26, 2018 a DRAFT Work Schedule was presented to the Board for information and discussion. CMRB Administration was directed to work with members of the Technical Advisory Groups (TAGs) to update the DRAFT Work Schedule.
- The DRAFT Work Schedule develops a path forward to meeting the timeline and requirements of the *Calgary Metropolitan Board Regulation*.
- To update the Work Schedule, TAG supports using the City of Calgary Corporate Project & Asset Management (CPAM) as a resource. CPAM staff act as internal consultants to other business units within the City organization.
- CMRB Administration has had an initial intake meeting with one of CPAM's professional Project Management Consultants to provide them with an overview of the CMRB and its mandate and the DRAFT Work Schedule.
- The Project Management Consultant is proposing two workshop meetings with TAG in support of refining the Work Schedule:
 - The first meeting would have an education focus, discussing matters related to governance including roles and responsibilities.
 - The second meeting would focus on refining and enhancing the Work Schedule.
- The first Project Management workshop with TAG is tentatively scheduled for January 18, 2019.

1. Interim Regional Evaluation Framework (IREF) Consultant Request for Qualifications (RFQ) Update

- As part of the approved Interim Regional Evaluation Framework (IREF) process, there is a requirement for a third-party review of IREF applications. These third-party reviews may be completed by a subcommittee of TAG members or by an external consultant.
- On November 8, 2018, the Land Use Committee directed CMRB Administration to work with TAG members on preparing a Request for Qualifications (RFQ) to find qualified external third-party IREF consultants.
- To build the RFQ, CMRB Administration held a workshop with TAG members at the November 16th TAG meeting.
- The workshop identified the key requirements a consultant must have to be selected as a qualified IREF third-party consultant. It also defined the term "Conflict of Interest" in relation to third-party external consultant reviews.
- CMRB Administration has incorporated TAG input into the RFQ and will be posting the RFQ on the Alberta Purchasing Connections with a closing date of December 20, 2018.

2. IREF Interpretation Guide Update

- On November 8, 2018, the Land Use Committee directed CMRB Administration to work with TAG members to review and update the IREF Interpretation Guide. The purpose of the guide is to increase the transparency of the IREF process by outlining further details around the IREF application review process.
- CMRB Administration has received comments from TAG members on the IREF Interpretation Guide and will be reviewing the comments with TAG members at the November 30, 2018 TAG meeting.
- CMRB Administration will update the IREF Interpretation Guide and provide it to the Land Use Committee for its decision at the January Committee meeting.

3. Regional Employment Analysis Update

- On May 10, 2018, the Land Use Committee directed CMRB Administration to undertake a study to determine employment projections by region and by major employment area.
- CMRB Administration selected Applications Management Consulting to complete the projections (the study is now called the Regional Employment Analysis).
- Applications Management presented its DRAFT approach to the Regional Employment Analysis to the Land Use Committee on November 8, 2018.



- Applications Management will be conducting its first TAG workshop on November 30, 2018 to garner input from TAG members.
- Results of the TAG workshop and follow-up analysis are tentatively scheduled to return to Land Use Committee for discussion at the January 2019 meeting.

4. Communications, Consultation, and Engagement Update

- On November 8, 2018, the Land Use Committee directed CMRB Administration to work with TAG members on a communication, consultation, and engagement framework.
- The intent of the framework is to create a common understanding of the purpose, goals, and indicators of success relative to the communications, consultation, and engagement work to be undertaken by the CMRB. This will be used to find a qualified consultant or consultants to begin communications, consultation, and engagement work on behalf of the CMRB.
- CMRB Administration held a workshop with TAG members at the November 16, 2018 TAG meeting to discuss what should be contained within the framework. CMRB Administration is working to take those workshop inputs and adapt them into a draft framework for TAG review.
- Results of the TAG workshop and DRAFT communications, consultation, and engagement framework will be presented to the Land Use Committee at the January meeting.

5. Growth Plan Consultant Update

- By the end of 2018, the CMRB Board members will have participated in two visioning sessions, with the potential for more as necessary.
- The purpose of the visioning workshops is to build the vision and values of the CMRB ("Region Building"). These will inform the growth planning process and other processes to be undertaken by the CMRB.
- With the vision and values of the CMRB being identified, and given the timelines imposed by the *Calgary Metropolitan Region Board Regulation*, it will be important to move forward with selecting a Growth Plan consultant to support the members in Q1 2019 ("Plan Building").
- The role of the Growth Plan consultant will be to support the CMRB in planning for key elements of the Regulation (more focused visioning and values exercises) and to establish the "how" of building the Growth Plan (detailed direction, policies, etc.).
- CMRB Administration will bring forward more information about a Request for Proposal for a Growth Plan consultant to the Land Use Committee for its consideration at the January Land Use Committee meeting.
- CMRB Administration will collaborate with TAG to identify the information and discussions/workshops necessary to develop the Request for Proposal.

Summary

- As part of the process of member education, CMRB Administration has been working to host Speakers Series lectures at Committee and Board meetings.
- To date, CMRB Administration has coordinated presentations from Bow River Basin Council, Alberta Environment and Parks, Miistakis Institute, Insurance Bureau of Canada, City of Calgary (water), MD of Foothills and Town of Okotoks joint presentation (service optimization), and Peter Calthorpe.
- CMRB Administration is currently investigating other potential Speakers Series topics and hosts, and is seeking input from the Committee on topics that are of interest to it.
- CMRB has reached out to Hemson Consulting, based in Ontario, who have been identified as leaders in fiscal sustainability at the regional scale. Hemson Consulting has been active in Southern Ontario over the past 30 years consulting in the area of growth management.
- Hemson Consulting would provide a Speakers Series lecture discussing the relationship between fiscal sustainability and major regional planning choices. Their proposed discussion topic is included below.



Request

CMRB Administration requests that the Land Use Committee provide suggestions on potential Speakers Series topics that are of interest to the Committee.

1. Proposed Hemson Consulting Ltd. Discussion Topic

"It is often supposed that accommodating growth through intensification can rely on existing infrastructure capacity relative to greenfield development. While often the case, there may not be sufficient capacities for large-scale growth and certain aging infrastructure may not really have the expected capacity. Retrofitting existing infrastructure or inserting new facilities into developed areas can be very expensive, such as new central city parkland or upgrading water and sewer trunks. As well, major decisions may need to be made between accommodating growth in the core urban area versus surrounding metropolitan communities (e.g. larger Airdrie and Okotoks versus contiguous growth on Calgary). We would draw on our experience in the Toronto area and southern Ontario as well as Ottawa, Halifax, Vancouver and Edmonton."

2. Presenter Bios

RUSSELL MATHEW, Partner, Hemson Consulting

Russell Mathew is a Partner with Hemson Consulting Ltd, with 33 years of professional experience. Russell is widely known for his expertise in the areas of demographic and economic forecasting and land economics.
