### 4. Friends of Calgary Airport-Banff Rail Presentation

The Committee received a presentation from Bruce Graham of Friends of Calgary Airport-Banff Rail, and Adam Waterous of Liricon Capital (project proponent). Discussions and questions centered around effects on wildlife, CP Rail and Alberta government participation/interest, Parks Canada feedback, costs, benefits (economic development, connectivity for the region, workforce



issues and tourism), and next steps. A motion to consider scheduling a presentation to the Board and potentially providing a letter of support was suggested, however most members felt this was premature and should remain at the Committee level. Presentations from other groups in this industry were encouraged.

- Environmentally Sensitive Areas Database initiative a RFP was also posted to APC and closes October 11, 2022;
- Project Charters for the scoping steps for the Regional Transportation and Transit Master Plan (RTTMP) initiative and Water Roadmap Update will come forward to September 16, 2022 Board meeting;
- o Indigenous Relations initiative— CMRB Administration retained the services of Forum Consulting as per the Board approved Charter. Outreach has begun to member municipalities on how they would like to participate in the development of the additions to reserve (ATR) framework. CMRB Administration will be sending out a request for participation in the development of Terms of Reference on initiative #4:



Celebrate through partnerships and plan for stories from the land with third parties. CMRB Administration is in dialogue with Councillor Breaker of Siksika Nation about Board members attending an event on September 30, 2022 at the Nation. More details will be forthcoming and circulated once received.
