8. Framework Water Governance

Motion: That the Calgary Metropolitan Land Use Committee and Intermunicipal Servicing Committee:

- 1. Recommend to the Board that meetings be scheduled with the Minister of Municipal Affairs and Minister of Environment and Parks, and at those meetings the Board request the Government's views regarding the objectives of this Board and the timing of it's work. In addition, that the Board use that opportunity with the Ministers to advise them of matters that are collectively important to CMRB, particularly regarding water issues in its many contexts.
- 2. That CMRB Administration, if possible with the advice of TAG, be directed to prepare all such documents as are required as background and briefing for the Board at its next meeting to give effect to the above.

10. Growth Plan Consultant RFP Timeline
